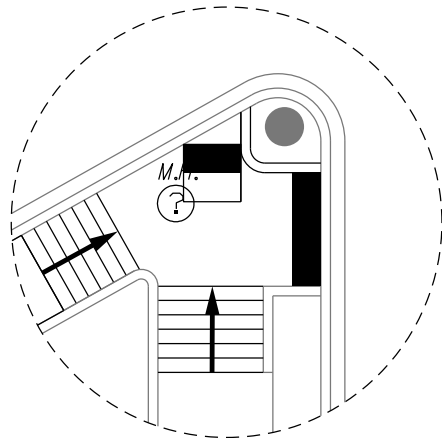
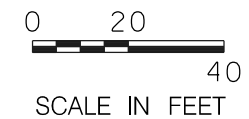

**CONSTRUCTION NOTES:**

1. REMOVE AND REPLACE RAMP (TYP.)
2. REMOVE AND REPLACE RAMP WITH DIRECTIONAL RAMP
3. REMOVE AND REPLACE RAMP WITH 5' LONG RAMP
4. REMOVE AND REPLACE RAMPS WITH 4' LONG RAMP ON NORTH SIDE, PLACE PAVERS ON EAST SIDE, 6' X 2'; SURROUNDING CONSTRUCTION TO BE DIRECTED BY ENGINEER
5. REPAIR AND REPLACE BRICK SIDEWALK, 16' X 12'
6. REPAIR AND REPLACE PCC SIDEWALK, 15' X 15'
